If the PFA was issued by a judge OTHER than Judge Cordaro or Judge George, then schedule the ICC hearing for a date that is not less than ten (10) days from the arraignment, and the hearing shall be held before the Judge who is assigned PFAs for the month, according to his/her ICC Schedule. (Ex.: If a Defendant is arraigned on January 27th, the hearing should be held after February 6th, and should be scheduled before Judge George, since he is the PFA Judge during February.)
